- Items can only be viewed at the lot on the corner of Tigris River Valley Rd. and Restore Hope Ave., Fort Drum, NY from 8 a.m. to 4 p.m. on auction days. No additional viewing after 4 p.m. Saturday – Bill of Sale or SF97 will be required to enter the lot after Saturday.
- Bids will be opened and reviewed starting Monday. Winning bidders will be notified by telephone starting Monday or Tuesday. All items that received bids are typically notified within two weeks. Tied bids will be determined by first received. You must accept or pass on the item at the time of the call – only items you are a top bidder on at the time of the call can be discussed.
- **Winning bids must be paid for with cash, money order, or credit card within 24 hours of notification (credit card over the phone, cash/money order in person – 10783 Chapel Dr.). All items must be removed within 48 hours of notification or a storage fee of \$20/day will begin accruing after 48 hours.**
- **Minimum bid is \$500 unless posted otherwise. All bids must be received by 4 p.m. Saturday to be eligible.**
